

**MINUTES OF THE DEVELOPMENT REVIEW MEETING HELD ON 18-02-2009 AT
DUMBURNAGAR BAC HALL UNDER THE CHAIRMANSHIP OF HAN'BLE CHIEF
MINISTER AT DUMBURNAGA RD BLOCK**

Venue :- BAC Hall at Dumburnagar. **Time:-**02:00 pm. **Date:-** 18.02.2010.

Agriculture & Horticulture:-

1. The food grain production of 3185 MT compared to total demand of 13,172 MT is too less. Agriculture Department to plan for bringing additional land under cultivation so that the productions demand gap can be bridged. The figures for production of total Agri produce appeared to be abnormal, therefore, a fresh survey on cultivable land, area under cultivation and total food grain production will be done within **one month**. The Agriculture Department to target 3400 ha land for '**Aus Paddy**'. Dy. Director, Agriculture to identify suitable land for "jhum cultivation through modern method". One **team from State Headquarter** will be sent for conducting survey and preparing action plan to bring new areas under cultivation. The Principal Secretary, Agriculture may also visit with State level officers in the last week of March,2010 and hold a review meeting on Agriculture & Horticulture activities.

Horticulture Department to do soil testing at different ADC Villages for identifying best suitable crops for Gandacherra Sub-Division. The Deptt. should aim to cover 170 ha of land under vegetable cultivation. Multicroop Horti Nurseries will be set up by Horti Deptt. to provide planting material and use them for demonstration purpose. The fund will be arranged from NREGA.

Irrigation:-

2. There was a difference between figures submitted by the Agriculture Department and Irrigation Department on irrigable land. Joint survey by officers of Agriculture Department & Water Resource Department to be done to ascertain actual '**irrigable land**' and '**land under irrigation**' presently. New LI schemes are required at Laxmipur ADC Village. Water Resource Department to ensure that the "non-functional" schemes at Tuichakma, Laxmipur are to be made functional within **next 15 days**. **The SE, Irrigation should visit atleast once in a month to Gandacherra Sub-division for reviewing LI/MI schemes with focus in interior areas**. Power Department will provide separate transformer at Tuichakma for LI Scheme by **28-02-2010**. The SE, WR has been requested to give priority in providing materials to Gandacherra & Kanchanpur Sub-Divisions. 35 ha of new area will be brought under irrigation by the end of **2009-10**.

ARDD:-

3. One brooder house will be constructed at Rashyabari. Principal Secretary, ARDD has been requested to post some '**Fodder Development Officers**' in Gandacherra Sub-Division and one Doctor at Raishyabari Veterinary Centre. The Principal Officer, ARDD to put efforts for increasing no. of SHGs working in ARDD sector. Animal and live stock check up health camps to be organized at Raishyabari, Tuichakma & Dalapari village by **1st week of March,2010**. The poultry development & cattle rearing to be focus area for income generating activities in the Block.

Fisheries:-

4. As such, the total production (1323 MT) exceeds the requirement (780 MT) of Gandacherra Sub-Division due to presence of Dumburnagar lake. However, action plan for bringing new areas under fish culture to be implemented. All the water bodies created under NREGA to be supplied fishery inputs.

POWER:-

5. Out of 216 habitations, 112 have been connected and 104 habitations are unconnected. The 65 villages will be covered under RGGVY and remaining 39 under other schemes in a phased manner. During 2009-10, nine habitations (7 under BRGF, 2 under BADP) will be connected. The TSECL officials will conduct **complete survey** of all the unconnected habitations in consultation with Chairpersons of VCs and take a certificate to this effect from them. The survey to be completed by **28-02-2010**. The MD, TSECL may review the progress of Dumburnagar RD Block regularly.

Drinking Water:-

6. SE,DWS informed that there are 20 deep tube wells, functioning in 12 ADC villages. 7 ADC villages will be provided with piped water supply by end of 2011-12. At present, there are 30 FC, 89 PC and 91 NC paras in Dumburnagar Block. The department will install 12 deep tube wells, 124 mini bore tube wells and 199 ring wells during the present financial year. The water supply through tankers in different paras of Dumburnagar Block was not satisfactory. **The SE, DWS was instructed to ensure supplying of drinking water through tankers at all the places as per demand by 21-02-2010.** In case, tenders are not finalized for hiring, the work should be executed departmentally. **SE,DWS to visit Gandacherra Sub-Division once in every week to address drinking water problems.**

HEALTH: -

7. The SDMO, Gandacharra briefed about health scenario in the Sub Division. He was instructed to keep close watch on health matters and take prompt actions on receiving any adverse information. The Director, Health & Family Welfare Department was requested to extend Sub Divisional hospital in Gandacharra from 50 beds to 100 beds. **One Blood Bank** to be established at Gandacharra. The food supplier to be immediately decided by SDMO for Raisyabari PHC.

NREGA :-

8. Total **66.74 person-days per family** have been created which includes 40 person-days of 2009-10 and 26 from spill-over fund. On being asked all the Chairpersons of Village Committees expressed satisfaction over implementation of NREGA. BDO was instructed to ensure that no group leader in any form is engaged under NREGA. No compromise on out put except in case of **Old/ill** people will be done. Another 30 to 40 person days during February to

March, 2010 to be targeted. The plantation of horti crops, tea, rubber etc. will be encouraged under NREGA.

ROAD CONNECTIVITY:-

9. There are six “1000 +”, eleven “500 +”, forty one “250 +” and one hundred twenty eight “below 250” habitations in the block out of which three Nos. “1000+”, four Nos of “500 +” and four Nos. of “250 +” habitations have been covered by PWD. The HSCL to complete connecting **three Nos. of “1000 +”** habitation with all whether road by **end of March, 2010**. The reporting format and presentation of road connectivity done by PWD was not satisfactory. The PWD to prepare fresh report on road connectivity. The D.M & Collector, Dhalai will review and help the PWD in preparation of fresh report. The Superintending Engineer, PWD promised that the Bailey bridge at Laxmipur Village will be completed within **April, 2010**. The uncompleted drainage (around 300 mtr.) in Gandacharra market is to be completed immediately. In case the old Agency can not execute the work, it should be re-allocated to new Agency or to be executed departmental. The SDM, Gandacharra will extend full co-operation to the PWD on this matter.

MISC :-

10. The Hon’ble MLA , 44 – Raima Valley Constituency requested for taking up some new diversion schemes He also requested for placing one high capacity rig machine in the Sub-Division for installing deep tube wells. Hon’ble MLA informed that 4 Nos. of S.B.Schools and 10 Nos. J.B. Schools are completely closed and no teacher attend schools. The Deputy Director, Education and Inspector of schools were requested to take disciplinary action against the teachers.

11. Hon’ble Minister, Agriculture stressed on monitoring of developmental schemes specifically by public representatives. PRI representatives to motivate farmers to take up new methods of agriculture for higher productivity.

12. The sports complex to be taken up by PWD immediately. The SDM to hand over the land at new location near the site identified for the Polytechnic Institute.

13 The SDM to identify land for Town Hall with 600 to 800 capacity in consultation with elected representatives. A land proposal for setting up of ITI should be immediately send to the Industry Department.

14. The Principal Secretary to the Chief Minister was requested to take up the matter with the Urban Development Department and send a team headed by Director, Urban Development Department along with Chief Engineer (PWD) etc. to see the feasibility of making Gandacharra as Nagar Panchayat. The SDM, Gandacharra to prepare a map of main areas of Gandacharra town and identify the areas which can be included to the Nagar Panchayat within **15 days**.

15. The S.P. Dhalai was requested to ensure that all the public vehicles are parked at Motor stand and not in the market area.

16. The PWD will prepare drawing, estimate and construct one new Dak Banglow at present site of Revenue Dak Banglow. The boundary wall of the Revenue Dak Banglow will also be done by

PWD. The new Revenue Dak Banglow should have Conference hall, dining hall at ground floor and some VIP suits, rooms etc. in first floor. The SDM will prepare a site map of the present area and hand it over to PWD within **10 days**. A quarter complex at old PWD Dak Banglow will be taken up by the PWD.

17. The Executive Engineer, Rural Development Department will prepare estimate and execute the maintenance of existing Revenue Dak Banglow building.

18. During public interaction, it was decided that one PHC will be set up at Hatimatha. Director, Health may take action accordingly. D.M. & Collector, Dhalai to prepare a proposal for **Growth Centre at Hatimatha** with provision for motor stand , market sheds , market stalls, children park, teachers barracks etc. and send it to the Planning Department within **30 days**. BDO, Dumburnagar to install one **Mark –II drinking water** source at Rohida para within **7 days**.
