

**MINUTES OF THE MEETING HELD AT CHAWMANU ON CONTROLLING  
MENINGITIS UNDER THE CHAIRMANSHIP OF HON'BLE MINISTER, HEALTH &  
FAMILY WELFARE DEPT.**

**Venue :-** Chawmanu BAC Hall **Time :-** 11.00 pm. **Date:-** 08.03.2009.

1. The CMO, SDMO & MOIC briefed about the overall health scenario of Chawmanu & Manu RD Block area. The CMO, Dhalai stated that the total 307 nos. health camps have been conducted in last one and half months. The CMO, Dhalai reported that prophylactic dose of antibiotic was given to every person under whole Chawmanu Block area and 3(three) panchayets of Manu Block from 27-02-2009 to 01-03-2009.

2. The SDMO, LTV reported that eleven nos. of long range health camps are being conducted starting from 27-02-2009 to 09-03-2009 to cover 14 ADC villages under Chawmanu area.

3. The CMO, Dhalai to prepare an action plan for having special health camps in Gandacherra Sub-Division.

**(Action by CMO,DLI)**

4. It was reported that medical officers posted at Manikpur PHC are not staying at Manikpur. It has been instructed that the Doctors posted at Manikpur PHC must stay at Manikpur otherwise the Director; Health & Family Welfare should initiate serious action against them.

**(Action by CMO,DLI)**

5. Requirement of fund for conducting health camps was raised by the BAC members. It was assured that the fund will not be a hurdle for providing health care to the poor patients. The fund presently available under NRHM for various purposes in the district should be utilized for conducting health camps, purchasing medicines and hiring of vehicles etc. The expenditure will be reimbursement by the state government later on.

**(Action by CMO,DLI)**

6. The SDMO, LTV and MOIC, CMN requested for providing reimbursement of mobil charges to the health officials. This will help in improving communication for early detection and treatment of patients affected by meningitis disease.

**(Action by DIR, HEALTH, AGT)**

7. Pamphlets will be distributed to general public, School students, ADC representatives for publicity and awareness generation against meningitis disease. This will be done by the CMO, Dhalai.

**(Action by CMO, DLI)**

8. Additional training will be given to MPWs for use of medical kits for test purpose. The CMO, Dhalai to work out a plan in consultation with the DHS, Agartala

**(Action by CMO, DLI)**

9. The MOIC, Chawmanu PHC to ensure proper hygiene in & around PHC area. The bleaching powder should be used for decontamination of hospital premises.  
**(Action by MOIC,CMN)**

10. It was emphasizes that strong surveillance need to be maintained by all concerned namely medical officers, MPWDs, ASHA workers and elected representatives. Big posters provided by the Director of Health Services to be displayed in suitable locations like along roads, govt. buildings, panchayet ghar, community hall etc.  
**(Action by CMO,DLI)**

11. In every Panchayet area, atleast 5(five) big hoardings should be displayed on awareness generation against meningitis disease.  
**(Action by CMO)**

12. The BDOs to ensure drum beating in **every market** day upto 30-04-2009 for general awareness against meningitis disease.  
**(Action by BDO,MNU/CMN)**

13. It was stated that the construction of health sub-centre at Labancherra under Manu RD Block is yet to be started. The construction works could not be taken up due to the objection by the Forest Deptt. on land matter. The DFO, Manu has been requested to look into matter personally and get the land clearance as early as possible.  
**(Action by DFO,MNU)**

14. The construction of drinking water treatment plan at Manikpur has been pending for long back. The EE, DWS to look into the matter and ensure that the construction should be completed in next one month.  
**(Action by EE,DWS)**

15. Some syntax tanks of capacity 500 ltrs. will be placed in some paras where supply of potable drinking water through water tankers is possible. This will help in storing drinking water at difference paras. The EE,DWS to ensure supply of syntax tanks.  
**(Action by EE,DWS)**

16. It was reported in the meeting that the many AWCs under Chawmanu & Manu Block area are not functioning at all. The Hon'ble Minister, Health has asked a detailed separate report on functioning of AWCs in these 2(two) blocks. DM, Dhalai to send the report.  
**(Action by CMO/SDMs/DISE)**
