

TOUR NOTE OF ABHISHEK SINGH, IAS, D.M & COLLECTOR, DHALAI DISTRICT FOR THE MONTH OF OCTOBER, 2011.

19-10-2011

I visited the Longtharai RF to over see the on-going survey work for the Longtharai RF Mouja under Longtharai Valley Sub-Division. The SDM, LTV and Sri L. Darlong, DC accompanied me during the visit. I interacted with the Settlement Officer and ASO, Tehsilder and Amin engaged for the work and was also briefed regarding the working and issue related to ETS machine. The following issues emerged during the said visit which require immediate attention of all concerned for necessary action.

1. Atleast three nos. of teams should be formed within Longtharai Valley Sub-Division for taking up survey in three Revenue Moujas at a time. For this, the team formed for MCRF Mouja may be ensured to have completed training & put to the survey work in the MCRF Mouja at the earliest.
2. It is observed that only one or two members of the team can operate the ETS machine during the survey which makes the whole exercise very much dependent on the key persons. It should be ensured that each team must have two to three persons who can operate the machine for daily operation.
3. The timing of daily survey should be advanced so as to derive more working time per day during dry season. The survey team alongwith security should start by 8:00 am so as to complete the survey process and return the base before the early sunset in winter season. SDM, LTV shall take up the matter with the SDPO and concerned TSR Bn for early departure of survey teams in the morning.
4. The back up from the memory card should be taken frequently to avoid any data loss due to malfunctioning. The coordinates and the survey points should be tallied with the digitized physical map after completion of each sheet so as to correct & minimize the errors at the earliest.
5. A memory card is reported to have infected with virus. It shall be ensured to be checked by expert at Agartala and repaired immediately. The data available on the card should be retrieved for use of survey team by DLRS.

6. The action plan for covering of all the stages of three ongoing moujas (including MCRA) shall be prepared & followed strictly.

7. The daily reporting by the team should be reviewed by the settlement officer & ASO daily to ensure progress of the survey operation is maintained.

Similar steps shall also be taken by the SDM, GNC for the survey operation in Gandcherra Sub-Division.
